Exhibitor shall be responsible for costs and reasonable attorney fees necessary to resolve any breach committed by the Exhibitor. CNHBA assumes no responsibility for calling back in the following year any Exhibitor who moves out prior to the official close of the Show, or who fails to pay CNHBA for Exhibitor's space, or who otherwise commits any other breach of this contract. In entering this contract, Exhibitor agrees to comply with and be bound by all rules and regulations of the Show, which are available to the Exhibitor at www.buildcnhba.com. Exhibitor is solely responsible for any loss, damage, or claim arising as a result of Exhibitor's property being displayed or used for exhibition on the Show premises, and where permitted by law, shall hold CNHBA and the Show harmless for any claim therefore.
